# **Policy and Commitment of Metal Conflict-Free**

As a member of the electronic industry supply chain, LTK has committed not using or purchasing conflict metals derived from minerals being sourced from Democratic Republic of Congo (DRC) conflict areas. LTK has taken due diligence within our supply chain and formulated its policy to ensure customers' rights and fulfill our social responsibility. We herein declare the metal Conflict-Free on products supplied to customers:

### Not to purchase conflict minerals produced in the conflicts areas

Assure "DRC Conflict-Free" for the metals of gold (Au), tantalum (Ta), tungsten (W), cobalt(Co) and tin (Sn) are not derived from or sourced from mines in conflict areas of the Democratic Republic of Congo (DRC), or illegally taxed on trade routes, either of which are controlled by non-governmental military groups, or unlawful military factions. Trade routes not confirmed to be "Conflict Free" include direct exports from the DRC, as well as exports through Rwanda, Uganda, Burundi, Tanzania and Kenya (countries of whom the U.N. Security Council note are global export routes for DRC-mined minerals).

# Strive to require the upstream and various raw materials suppliers to refuse to use conflict minerals from the conflict areas

To ensure suppliers comply with this policy, LTK has required all metals suppliers to declare on prohibiting the Use of Conflict minerals. We would like to confirm metals used in products sold to LTK are "DRC Conflict-Free".

### 无冲突金属政策与承诺

身为电子产业供应链的一员,乐庭承诺不使用及购买来自于刚果民主共和国等 冲突区域所产出之冲突金属,亦已进行详细供应链调查,并写成政策,以维护客户 权益并善尽社会责任。本公司的无冲突金属政策如下:

## 不采购来自冲突区域所产出的冲突金属

确保金(Au)、组(Ta)、钨(W)、鈷(Co)、锡(Sn) 这类金属并非透过无政府军团或非法集团,由刚果民主共和国冲突区域之矿区开采或是循非法走私途径取得。此外,下列国家出口之金属皆不符合「无冲突规范」:刚果民主共和国(DRC)、卢安达、乌干达、蒲隆地、坦尚尼亚、肯亚(联合国安全理事会认定上述国家皆为刚果矿脉之矿产)。

# 致力要求上游及各原料供应商,拒绝使用来自冲突区域的冲突金属。

为确保供应链厂商亦遵照此一政策,本公司已要求乐庭的所有金属供应商,均 需填写禁用冲突金属承诺书。本公司保证任何出售于客户之产品所含金属皆符合无 冲突规范。
